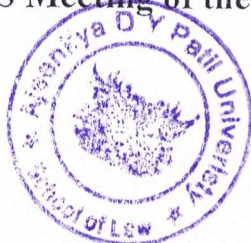
\*Annexure 1: Program Structure of BALLB
