COOPERATION AGREEMENT BETWEEN UNIFACVEST AND AJEENKYA D Y PATIL UNIVERSITY

FACVEST University Center, hereinafter referred to as "UNIFACVEST", located at Marechal Floriano Avenue, 947, Centro, CEP 88.501-103 Lages, State of Santa Catarina, Brazil, in this act represented by its Magnificent Rector, GEOVANI BROERING, CPF 456.925.050-53, and AJEENKYA D Y PATIL UNIVERSITY (ADYPU), Pune, India, hereinafter referred to as "ADYPU", located at Pune, India, of the City of Pune 412105 ZIP Code, India, reorganized by UGC and presented in this act, both Higher Education Institutions, agree to celebrate and sign the present cooperation agreement to establish academic, scientific and technical cooperation programs, based on the following clauses:

1.0 The two universities will initiate and encourage the following activities:

- 1.1 Exchange of students for relevant academic programs both undergraduate studies or post graduate studies;
- 1.2 Exchange of faculty members as visiting scholars for teaching of courses and providing seminars in relevant academic programs;
- 1.3 Sharing of academic information/curriculum, course materials, library cooperation and suggesting improvements whenever deemed necessary;
- 1.4 Collaboration on research initiatives involving external national/international partners and international funding programs;
- 1.5 Mutual recognition for professional qualifications, including credit transfer;
- 1.6 Collaboration on staff training and development programs; and
- 1.7 Facilitating national development projects through involvement of experienced faculty and staff members.

1.2 - The parties agree to promote cooperation and networking among themselves, develop cooperation actions, programs, and projects and coordinate the joint execution of activities of an academic, scientific, technological, and cultural nature in areas of mutual interest. Likewise, they agree to promote training, continuing education and the improvement of their human resources, as well as the exchange of information in these areas, for their common benefit and that of the society they comprise.

1.3 - The signatory parties, based on the provisions of the first clause of this agreement, may enter into specific cooperation agreements. In them, they may mutually commit to:

- i. Advise the other party, at their request, in academic and technical areas of their competence.
- ii. Contribute to the training, continuing education and development of personnel of the other signatory party, which it sends.
- iii. Collaborate in teaching tasks in the disciplines of their competence.
- iv. Collaborate in and contribute to the exchange and mobility of academic and teaching staff, individually or in work centers, between their programs and units.
- v. Promote and facilitate the exchange of information and products of their academic, teaching, scientific-technological, research and development activities among them, as well as the joint use of visits and courses by experts, researchers and teachers from abroad.
- saw. Conduct academic programs or joint careers.
- vii. Develop joint cultural and extension activities.
- viii. Form specific thematic networks and / or telematic networks, for the purposes of research, teaching, service to the environment and cooperation between them.

The actions listed above made in this clause is illustrative in nature, is not exhaustive and will not limit the possibility of other common actions that contribute to the realization of the object of the cooperation agreement.

1.4 - The terms, conditions and procedures for the execution of each of the projects that may be implemented will be established through prior agreements between the parties in annexes, which must be endorsed by the Rectors of both Universities.

1.5. - The results achieved through the actions, programs, projects and works carried out within the framework of this agreement, will be jointly owned and may be published jointly or separately by the parties, indicating their origin and authorship. In general, in all joint projects of any nature, the contribution and / or participation corresponding to the other party will always be indicated. For the development of the various joint activities, a framework agreement will be drawn up in each case that specifies the financing mechanisms and modalities that each activity demands and the participation that corresponds in this regard to each of the parties.

1.6 - This agreement will be in force from the date of the subscription of the same by both parties, and will remain in force for a term of FOUR (4) years. Its renewal will be automatic for each subsequent year, unless one of the parties notifies by means of a note signed by the Rector the other of its termination with no less than sixty (60) calendar days prior to the expiration date. The use of the right of withdrawal that is accorded to any of the parties, will not generate or give the right to claim from the other, any amount of compensation for any reason. If, at the time of termination, the parties are in agreement and taking into account the spirit and objectives that underlie this Framework Agreement

for Cooperation and Collaboration, they will determine the form and measures necessary for its best termination.

1.7- This agreement will be in force as of the date of its subscription by both parties, and will remain in force for a period of TWO (2) years. Its renewal will be automatic for each subsequent year, unless one of the parties notifies the other by means of a note signed by the Rector, of its termination with no less than sixty (60) calendar days prior to the expiration date. The use of the right of rescission that is agreed to either party will not generate or entitle the other to claim any compensation for any reason. If it is found at the time of the termination, activities pending completion, the parties by common agreement and taking into account the spirit and objectives underlying this Cooperation and Collaboration Framework Agreement, will determine the form and measures necessary for its better completion.

1.8- This agreement does not limit the right of the parties to enter into similar agreements with other Institutions. The signatories undertake to try to compose and resolve autonomously and directly, extrajudicially, any difference and / or controversy derived from the application and / or interpretation of this Agreement. In the event of not reaching an out-of-court solution, the signatory parties to this agreement, for all legal purposes, set a special address at those indicated in the heading, where all judicial or extrajudicial notifications will be valid.
