e. Deferred Advertisement Expenses

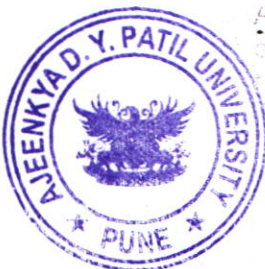
