BA-LL.B.

Duration: 5 Years

Eligibility: 10 + 2 in any stream with minimum 45% marks

LL.B.

Duration: 3 Years

Eligibility: Bachelor's degree in any subject with not less than 45% aggregate marks.

LL.M.

Duration: 01 Year

Eligibility: LL.B. or an Equivalent Degree with 50% marks.
