

Powers and functions of Board of University Teaching and Research

(Section 27 of Statues of ADYPU)

1. The Board shall have the power to control, regulate and co-ordinate teaching, training and research and to promote industry-university interactions.

2. In particular, and without prejudice to the generality of the foregoing provisions, the Board shall exercise the following powers and perform the following functions:

- a. to recommend to the Academic Council the conduct of instruction, teaching, training and research in the University;
- b. to recommend to the Academic Council the requirements regarding teachers in the respective subjects;
- c. to recognize research guides;
- d. to determine the programmes of instruction, teaching, training and research, and decide the nature and extent of the work that the teachers may be called upon to undertake;
- e. to co-operate and collaborate with other universities, institutions, authorities or organizations for research and advisory services;
- f. to approve subjects for research for various degrees and other requirements for research degrees

3. The Board shall ordinarily meet twice in a year.

4. The Vice-Chancellor or in his absence, a Dean of the Faculty nominated for the meeting by the Vice-Chancellor shall preside over the meeting of the Board.
