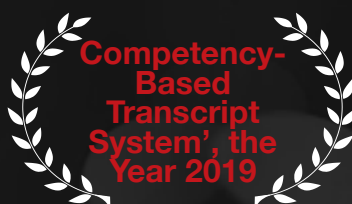

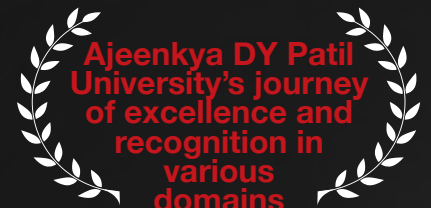

ADMISSION PROCESS & FEE STRUCTURE

(Admission Rules & Regulations: Applicable to both Indian and International Candidates)



Guidelines and Procedure

Constituent Schools and Departments of Ajeenkya DY Patil University need to follow the Guidelines and procedures while checking the eligibility for admission for both Indian and International Candidates. The eligibility of a candidate shall be processed within 30 working days of the start of the academic session.

a) General

Eligibility norms enumerated for the said Program are required to be compulsorily met by the candidates for admission to the concerned program of the University.

The process of verification of eligibility commences at the time of grant of the provisional admission and as such only eligible candidates are given provisional admission.

b) Procedure

Constituent Schools and Departments of Ajeenkya DY Patil University will ensure that:

1. Candidates fill up the admission form completely without any mistakes.
2. Candidate submits self-attested photocopies of documents required for verification of eligibility for admission.
3. The self-attested photocopies are verified with the originals and endorsed by the duly

authorized officer by the Director of the constituent school and head of department.

4. Only those candidates who fulfill the requirement of minimum marks or CGPA Grade points at the qualifying examination as prescribed for admission to the program are provisionally admitted.

5. Circulars issued by the University in respect of eligibility are followed strictly.

6. Eligibility rules are strictly followed while granting provisional admission to candidates.

7. In-eligible candidates are not given admission.

8. Original Leaving/ Transfer/ Migration certificate is retained by Ajeenkya DY Patil University.

9. A Transfer certificate from the college/ university last attended is to be obtained and submitted by the candidate seeking admission to a school/department within Ajeenkya DY Patil University.

10. The Ajeenkya DY Patil University and its constituent schools and departments will work out the equivalent percentage of marks against the grade if a candidate has passed class XII or the qualifying exam on the grade system from another International school or university for deciding eligibility.

11. A Candidate who has applied for re-evaluation of the marks obtained at the

qualifying examination may be admitted provisionally, provided he/ she submits the result of re-evaluation before 30th September of the admission year showing that he/ she has obtained the qualifying percentage of marks, failing which his/ her admission shall stand automatically cancelled.



Provisional admission

It has to be understood that all admissions will be provisional at the time of academic course commencement until the University grants final eligibility and confirms the admission.

a) Confirmation of admission

Every student shall be admitted to ADYPU provisionally till the time ADYPU confirms the eligibility of the student.

Every student admitted to the constituent school of the ADYPU shall apply the prescribed form for eligibility along with requisite documents mentioned in the application to the school in which he is admitted within the time limit prescribed for submission. The application and documents shall be checked by the concerned school and forwarded to the Eligibility Section of the University.

In the case of students migrating from other Boards/University the Migration Certificate must be attached to the application for eligibility. If the student is unable to submit a migration certificate along with the application for eligibility, the Head of the School may grant him some time for submission of the same.

The eligibility Section of the university shall scrutinize the application and documents submitted by the students provisionally admitted confirm the admission of the students who fulfill the eligibility norms of the University and send the list of such students to the concerned school.

The cases of students who have not submitted the migration certificate along with the application for eligibility shall be treated as provisional till the date up to which they have been granted permission to submit the same.

However, if the student fails to submit a migration certificate up to the extended date, he/she shall be considered ineligible for admission and the Eligibility Section will inform the Director of the concerned school accordingly and thereby the provisional admission granted to him shall be cancelled by the Director of the School.

The University is the sole authority to grant eligibility for admission to a student and confirm/cancel provisional admission and the decision taken by it shall be final.

b) Reservation Policy

Reservation of seats in courses offered by the University will be in accordance with the policy of the Government of Maharashtra in force at that time. The benefit of reservation will be available, only to the domiciles of Maharashtra.

1. Candidates from Maharashtra or outside of Maharashtra belonging to SC/ST/DTNT/ OBC must submit the caste certificate and validity certificate.
2. It should not be older than 6 months.
3. The courses for which the condition of minimum percentage of marks is required; a relaxation of 5% marks be given to the above-mentioned categories.

Wards of Ex-servicemen personnel and serving personnel including of police forces who receive Gallantry Awards (including Param Vir Chakra, Ashok Chakra, Sarvottam Yudh Seva Medal, MahaVir Chakra, Kirti Chakra, Uttam Yudh Seva Medal, Vir Chakra, Shaurya Chakra, Yudh Seva Medal, Nau Sena, Vayusena Medal, Mention in despatches, President's Police Medal for Gallantry, etc.
17. Children of Paramilitary Force and State Police personnel.
18. Reservation to the wards of Kashmiri Migrants / Refugees.

A combined horizontal reservation of 3 percent of the total seats in all categories will be given to physically challenged applicants. If an applicant is eligible for weightage in more than one category, the benefit of the same will only be given in a category where the highest weightage accrues to her/him.

If reserved seats remain vacant on the day of publication of Admission Offer letters, such seats will be treated as open and filled up in open competition based on merit.

To avail the benefit of reservation a certificate from a Competent Authority should be produced. The candidate (applicants) must indicate explicitly the category for which he/she wants to avail the advantage of reservation for admission. This option will, in no case, be allowed to be changed.

c) Allocation of Seats

The seats in the various programs will be allotted based on merit- ranking of the student and subject to fulfilling the minimum eligibility criteria for the program. The merit ranking is compiled at the end of each admission cycle. If the seats remain vacant another admission cycle is announced. The merit – ranking is arrived at by calculating the average of the score in the specified entrance test and the score of the personal interview.

d) Transfer/Migration Certificate Policy

Transfer/Migration Certificate will be issued based on the following guidelines:

i) A candidate who has appeared in an examination conducted by ADYPU and has passed the UG/PG examination conducted as per the scheme of studies may obtain a migration/transfer certificate after payment of the prescribed fees.

ii) A Migration Certificate is not a right it is only in the interest of the university and can be issued only after a proper scrutiny process.

iii) Students must apply requesting for TC/MC duly signed by the candidate and countersigned by a parent or legal guardian.

iv) The original application shall be accompanied by an original fee receipt, ID card (if issued), and dues clearance certificate.

v) All the final semester students who have completed their Program have to complete the No Dues Process before leaving the University campus. Thereafter, the students shall be handed over the transfer certificate on request during or after the Convocation ceremony.

vi) In case the student wishes to pursue his/her higher education at another University, the Migration certificate shall be sent directly by the ADYPU Student Support Division to the new University via speed post at a nominal cost. It shall be issued only after the receipt of an official email or application letter from the New University stating the request for a migration certificate.

vii) A transfer or Migration Certificate shall be issued only if the student has no dues.

viii) The fee to Ajeenkya D Y Patil University is an annual fee and not a semester fee. For the convenience of students and parents, it is charged in pre-specified installments.

ix) Students have to ensure that the fee is paid for the whole academic year.

x) Transfer / Migration certificate will be issued only once a year in July.

xi) While issuing the ADYPU Transfer / Migration certificate the previous Transfer Certificate / Migration certificate submitted by the student will not be returned.



Provisional Admission to Indian Candidates

a) Eligibility norms to be fulfilled by Indian Candidates.

Eligibility norms for various courses are given separately. The candidate must satisfy the norms prescribed for the course to which he/she desires to seek admission.

The candidates should have passed the entrance exam of the university and should have succeeded in the personal interview or test as applicable. The candidate should have submitted the requisite documents, admission form & application for eligibility before the due date.

A candidate is eligible for admission to a program in Ajeenkya DY Patil University, subject to the condition that he/she is not simultaneously undergoing any study program in any other University.

b) Non-Eligibility for Admission

A Candidate is not eligible for admission to a degree program in the University if he/she is simultaneously undergoing a degree program in any other University.

c) Submission of Documents for grant of eligibility

The Indian candidate needs to submit the following documents to be eligible for admission to the programs of Ajeenkya DY Patil University.

Undergraduate Programs:

1. Original Mark Statement or Transcript of Marks of Higher Secondary School Certificate

(HSC: 12th) Examination of the State Board or CBSE/ICSE Board

2. Original School Leaving Certificate from the School /Jr. College last attended.

3. Copy of the Caste Certificate (if applicable)

4. Candidates belonging to Reserved Category are required to submit copy of the Caste Certificate as well as Caste Validity Certificate.

5. Equivalence Certificate: Candidates who have been awarded a Diploma by the State Board of Technical Education from AICTE approved Polytechnic and seeking admission to either the First Year or Direct Admission to the Second Year of the Ajeenkya DY Patil University are required to submit an original Equivalence Certificate issued by the State Board of Technical Education

6. Address Proof: The candidates applying for admission to Ajeenkya DY Patil University are required to Submit a copy of their Aadhaar Card in support of the address mentioned by them in the application for admission. In case, an Aadhaar card is not available, the candidate may submit a copy of their electricity bill or copy of their passport. However, the candidate must submit the Aadhaar Card within 6 months of admission.

Post Graduate Programs:

1. Original Mark Statements / Transcript of Marks of all semesters/years of the qualifying degree examination passed from a recognized University.

2. Copy of the Passing Certificate / Degree Certificate issued by the University. In the event the candidate does not have either passing/degree certificate while applying for admission, he / she will apply for the time limit for submission of the same to the

Director of the School / Department where he is seeking admission and shall submit the same immediately on receipt of the same to the School.

3. Original Transfer Certificate from the College/ Institute last attended.

4. Original Migration Certificate of the University Migration Certificate from the University from which he/she has obtained degree examination. However, the candidates who have obtained a degree from Ajeenkya DY Patil University are not required to submit a Migration Certificate.

5. Caste Certificate (if applicable candidates belonging to the Reserved Category are required to submit a copy of the Caste Certificate as well as the Caste Validity Certificate.

6. Address Proof

The candidates applying for admission to Ajeenkya DY Patil University are required to submit a copy of their Aadhaar Card in support of the address mentioned by them in the application for admission. In case, an Aadhaar card is not available, the candidate may submit a copy of the electricity bill or a copy of their passport (First and last page). However, the candidate must submit the Aadhaar Card within 6 months of admission.

d) Norms for Attestation of Documents

Candidates shall attach self-attested copies of the documents listed above (as applicable) to the Application Form for Eligibility. Photocopies without self-attestation will not be accepted/considered.

e) Eligibility Process

The eligibility process is carried on as per statutory Authorities.

i. The ADYPU Eligibility Section will seek your original documents to check the eligibility of the required program and whether he/she meets the same.

ii. Based on step one, the Eligibility Section then prepares the merit list which shall be displayed or communicated to you via your official email ID.

iii. The Second round of eligibility is undertaken after receiving the pending list of documents of ineligible students.

iv. The eligibility section then prepares the Final merit list.

v. Post the final merit list, the online verification of all the documents will be followed as per the norms of the Eligibility Section.

vi. The original handover will happen after the process is completed and after the receipt of full fees.

vii. On completion of the entire process, original documents shall be returned before the end of the odd semester within the stipulated time period.

f) Return of Original Documents

All original documents submitted by the candidates shall be retained till the preparation of the final merit list and on completion of payment of the requisite fees duration of the program or till such time the candidate remains a student of the Ajeenkya DY Patil University and shall be returned to the candidate on completion of the program or if he / she leaves the program in between. However, the University will retain the original Transfer and Migration Certificates.

The students leaving the programs from Ajeenkya DY Patil University in between shall

be given a transfer certificate of the School where he or she was enrolled.

The original documents & transcripts submitted during the time of admission will be returned to you after full scrutiny by the ADYPU Eligibility Committee. This excludes the Transfer Certificate of your previous college.



Provisional Admission to International Candidates

a) Eligibility norms to be fulfilled by International Candidates

- Eligibility norms for various courses are given separately. The candidate must satisfy the norms prescribed for the course to which he/she desires to seek admission.

- The candidates should have passed the entrance exam of the university and should have succeeded in the personal interview or test as applicable. The candidate should have submitted the requisite documents, admission form & application for eligibility before the due date.

- A candidate is eligible for admission to a program in Ajeenkya DY Patil University, subject to the condition that he/she is not simultaneously undergoing any study program in any other University.

- Candidates passing the qualifying examination from a university or Board in India and abroad recognized by the University Grants Commission, India / Association of Indian Universities are only eligible for admission to programs of Ajeenkya DY Patil University.

b) Submission of documents by International Candidates for grant of Eligibility Undergraduate Programs:

1. Original Mark Statement & Passing Certificate/ Transcript of the examination held at the end of 12 years of formal education at School level [Equivalent to Higher Secondary School Certificate (HSC) Examination of Maharashtra State/CBSE/ICSE Board]

3. Copy of Passport

4. Copy of Person of Indian Origin Card (Only for PIO Candidates)

A candidate whose ancestors were Indian nationals and who is presently holding another country's citizenship/nationality, registered as PIO under the MHA scheme vide notification No.26011/1.4.98-F.1 dated 19.08.2002 falls in this category.

5. Copy of Overseas Citizen of India Certificate
A candidate registered as an Overseas Citizen of India under section 7 A of the Citizenship Act of India.

6. NRI Status proof

A candidate who is residing outside India and holds an Indian passport, who has studied and passed the qualifying examination from the schools/institutes in foreign countries will be considered as an International Student. This will include the candidates who have studied in schools/colleges in foreign countries even if affiliated to Boards of Secondary Education or Universities located in India.

8. Copy of valid Residential Permit (not applicable to candidates from Nepal & Bhutan)

The Foreign candidates are required to apply for and obtain a residential permit for their stay in India during the course of their studies. They will be required to apply to District Foreigners Registration Office, Pune within 14 days of their first arrival in India.

9. Copy of the NRI Status Proof

A candidate who is residing outside India and holds an Indian passport, who has studied and passed the qualifying examination from the schools/institutes in foreign countries will be

considered as an International Student. This will include the candidates who have studied in schools/colleges in foreign countries even if affiliated to Boards of Secondary Education or Universities located in India.

10. Copy of valid VISA (not applicable to candidates from Nepal & Bhutan)

11. Copy of valid Residential Permit (not applicable to candidates from Nepal & Bhutan)

The Foreign candidates are required to apply for and obtain a residential permit for their stay in India during their studies. They will be required to apply to the District Foreigners Registration Office, Pune within 14 days of their first arrival in India.

c) Norms for Attestation of Documents

Candidates shall attach self-attested copies of the documents listed above (as applicable) in neat and legible form to the Application Form for Eligibility. Photocopies without self-attestation will not be accepted/considered. All eligibility documents submitted by international students are to be attested by either by

a) Ministry of Higher Education in Home Country OR

b) India Mission/Embassy in Home Country.

d) Return of Original Documents

All original documents submitted by the candidates shall be returned after full scrutiny by the ADYPU Eligibility Committee. This excludes the Transfer Certificate of your previous college. However, the original Transfer and Migration Certificates will be retained by the University.

The students leaving the programs from Ajeenkya DY Patil University in between shall be given transfer certificate of the school where he / she was enrolled.



Lateral Entry Admission Guidelines

a) Eligibility

i. Migrated Student with Backlog Not Eligible for Second Year Admission: A student coming from another University shall not be eligible for Second Year admission or any other diploma student seeking admission for First Year, unless he/she is declared as passed in the preceding year of the former University.

ii. Student who has appeared for supplementary examination not eligible: All students who has appeared for any supplementary examination for improvement or passing or failed subject shall not be eligible for admission in Second Year.

b) Applicability

Admissions through lateral entry shall be considered, only if the credit mapping in the previous institution/university matches with the curriculum offered at ADYPU.

c) Reservation Policy

Reservation norms for different category candidates, as specified by the University policy shall be followed for admission to Second Year (lateral Entry, wherever applicable) in all undergraduate and postgraduate programs.

d) Number of seats

i. The number of seats for lateral admissions are not pre-determined. They shall be considered against the dropouts, seats remaining vacant, and students failed or debarred in the First-Year program.

ii. It shall not be more than ten percent of the approved strength of the program for the batch, subject to the final decision of ADYPU.

e) Submission of Documents for lateral entry

The student shall submit copies of the respective Marks Cards/ Grade Sheets/ Transfer Certificate/ NOC and other Certificates along with the Application for Transfer. In the case of International Students, a self-attested Passport Copy and Form C are mandatory.

f) Provision of Bridge Course

Candidates seeking lateral entry may be required to complete specified Bridge Courses as prescribed by ADYPU from time to time.

g) Marks/Credits

i. In case of SC/ ST and OBC candidates from Maharashtra the minimum marks for eligibility shall be as per the Government norms.

ii. Passed Diploma Course in Engineering and Technology with at least 50% marks (45% marks in case of candidates of Reserved Category categories and Persons with Disability belonging to Maharashtra State only) in appropriate branch of Engineering and Technology from an All-India Council for Technical Education or Central or State Government approved Institution or its equivalent OR

iii. Passed B.Sc. Degree from a University Grants Commission (UGC) recognized University with at least 45% marks (40% in case of candidates of Reserved Category categories and Persons with Disability belonging to Maharashtra State only) and passed HSC with Mathematics as a subject if students belonging to this category shall clear the subjects of Engineering Graphics/ Engineering Drawing and Engineering Mechanics of the first year Engineering Program along with second year subjects.

iv. Any other criterion declared from time to time by the appropriate authority as defined under the Act.

h) Attendance for lateral entry candidates

i. The basis of the calculation of the attendance shall be from the date of commencement of the classes prescribed by the University by its academic calendar.

ii. For the first semester/third semester (Lateral Entry) newly admitted students, the same shall be reckoned from the date of his/her registration to the program.

i) Completion of program

A student admitted in Second year under lateral entry process shall be required to complete the program within a stipulated time.

j) Academic Results

For students admitted to Second year (lateral entry), the result of the program shall be declared based on working out the CGPA as being practiced at the University currently.

k) Equivalence of Credits by Equivalence Committee

Every lateral entry candidate admitted in ADYPU after the completion of the admission process, he/she must ensure to fulfill the credit requirements, as per the guidelines laid by the ADYPU Credit Transfer Equivalence Committee.

- Students are required to adhere to the payment schedules for university fees.
- Detailed fee policies are available through the Accounts Department.
- Upon joining, students and their parents/guardians must sign the Fee Undertaking Policy.
- Full semester fees must be paid at the time of admission or readmission, or within one week of the program commencement with permission from the Dean of the School.
- Additional installments or fee payment extensions will not be granted.
- Access to academic resources may be restricted until installment fees are paid.
- Late fee payments are subject to penalties determined by the management.

v. Smoking and Tobacco-Free Campus Policy

ADYPU maintains a strict no-smoking policy within university buildings, enclosed workplaces, and vehicles used for work purposes. This includes all campus areas, including cafeterias, hostels, parking lots, and sports grounds. The use of electronic cigarettes is also prohibited on campus.

vi. Alcohol & Drug Policy

The University has a zero-tolerance policy towards alcohol consumption, possession, or use of illegal drugs on campus. This includes distribution, sale, possession, or consumption of alcoholic beverages and illegal substances. Violations will result in disciplinary action, including potential dismissal from the university.

vii. Parking

Acts of Misconduct

- Misbehavior towards faculty, staff, or fellow students.

- Casteism, untouchability, or any form of incitement.
- Any action derogatory to the status of women.

- Willful destruction of university property.
- Rowdy, intemperate, or disorderly behavior.
- Inciting discord, ill-will, or intolerance on sectarian or communal grounds.
- Disruption of academic functioning.
- Indulgence in disruptive activities related to assessments, examinations, or university functions.

Anti Ragging Policy

Annexure.1

POLICY FOR REFUND OF ACADEMIC FEES ON CANCELLATION OF ADMISSION

1. APPLICABILITY AND ENFORCEMENT:

- a. The Policy is applicable to all Undergraduate and Postgraduate Programs offered by Ajeenkya DY Patil University, Pune.
- b. The Policy will be effective for the Academic Year 2023 - 24 and shall have regulatory force on extent as well as future grievances over issues and matters covered herein.
- c. The Fees charged are for the full Academic Year and is to be paid at the beginning of the Academic Year.
- d. The Cut-off dates for admission will be notified by university separately by circular.

2. PROCEDURE FOR CANCELLATION / WITHDRAWAL OF ADMISSION:

- a. A student shall apply for cancellation of admission in the prescribed format (attached as Annexure I) to the University within the stipulated time frame.
- b. The University after following due procedure will cancel the admission of the applicant and shall refund the in accordance with Refund Policy to the student within stipulated time from the date of his / her receipt of written application in prescribed format.
- c. Along with the application, students are required to submit a copy of the fee receipt & copy of the cancelled cheque or bank account details from which the fees have been deposited.
- d. The refund shall be given only if the student has submitted an application for refund in the prescribed format failing which refund cannot be given. **RULES FOR REFUND OF ACADEMIC FEES** If a student applies to withdraw / cancel the admission from the program of study in which he / she is enrolled, the following system shall be followed for the refund of fees.

Category	% of refund of fees*	Point of time when Student applies for withdrawal/ cancellation of admission *
I	100%	If students cancel the admission before 15th October 2023 - After deducting Processing Fee of. ₹. 2,000/- balance fees will be refunded.
II	90%	If students cancel the admission between the period 15th October 2023 to 31st October 2023 After deducting 10% of total academic fees + Processing Fee of. ₹. 2,000/- balance fees will be refunded.
III	80%	If students cancel the admission between the period 31st October 2023 to 15th November 2023 After deducting 20% of total academic fees + Processing Fee of. ₹. 2,000/- balance fees will be refunded.
IV	50%	If students cancel the admission between the period 15th November 2023 to 30th November 2023. After deducting 50% of total academic fees + Processing Fee of. ₹. 2,000/- balance fees will be refunded.
V	0%	If students cancel the admission after 30th November 2023. No fees will be refunded the students has to pay full academic year fees.

The Fees chargeable are for the full Academic Year.

For the convenience of the students, the payment of fees is permitted in two instalments.

Notes

a. The Cut-off dates for admission will be as notified separately every year by Ajeenkya D Y Patil University as per directives of University Grant commission.

b. Admission after the last date will be treated as late admissions and the refund policy mentioned in the above table will not be applicable for such students. The entire amount of first year fees would be non-refundable in such cases.

c. Last date of admission may be changed / extended as per guidelines of UGC /governing authorities.

d. All days are inclusive in calculation.

e. In case of Non-Attendance of Student for second semester and if student requests for refund of second Instalment, No refund would be admissible. The entire fees of the second instalment would have to be paid by the student.

PROVISIONAL ADMISSION CANCELLATION

In case a student applies to withdraw / cancel his / her “Provisional Admission”, then for the refund of fees remittance of refund after deducting Processing Charges of ₹. 5,000/- or 5% of fees paid (Full fees applicable for the complete year), whichever is lower shall be considered.

REFUND OF FEES IN OTHER CASES :-

a. In case, the admission of student is cancelled on account of disciplinary action or violation of Anti-Ragging Regulations, Substance Abuse, or breach of the Code of Conduct or any other Rules & Regulations of the University, No Refund of fees is permissible.

b. In case, the admission of a student is canceled/terminated on account of non-fulfilment of eligibility criteria, no Refund of fees is permissible.

c. In any other case which is not covered in these rules, the decision taken by the Vice Chancellor and Registrar would be final and binding.

TRANSFER OF FEES IN CASE OF TRANSFER OF ADMISSION TO ANOTHER SCHOOL :-

1. In case the student applies for transfer of admission from one School of ADYPU to another School of ADYPU, the transfer application shall be processed and if approved by the University, the transfer of fees shall be as under:

a. If the student applies for transfer of admission to another school of the University before the commencement of the program, then 100% of fees shall be transferred to the other school. However, applicable administrative charges would be charged.

In case, the program fees are different, then the student will have to pay the difference in the fees, or else the amount will be adjusted in the next instalment/ refunded to the student.

b. If the student applies for transfer of admission to another School of the University, after commencement of the program, then the proportionate amount of academic fee shall be deducted and remaining amount after deductions shall be transferred to the other School.

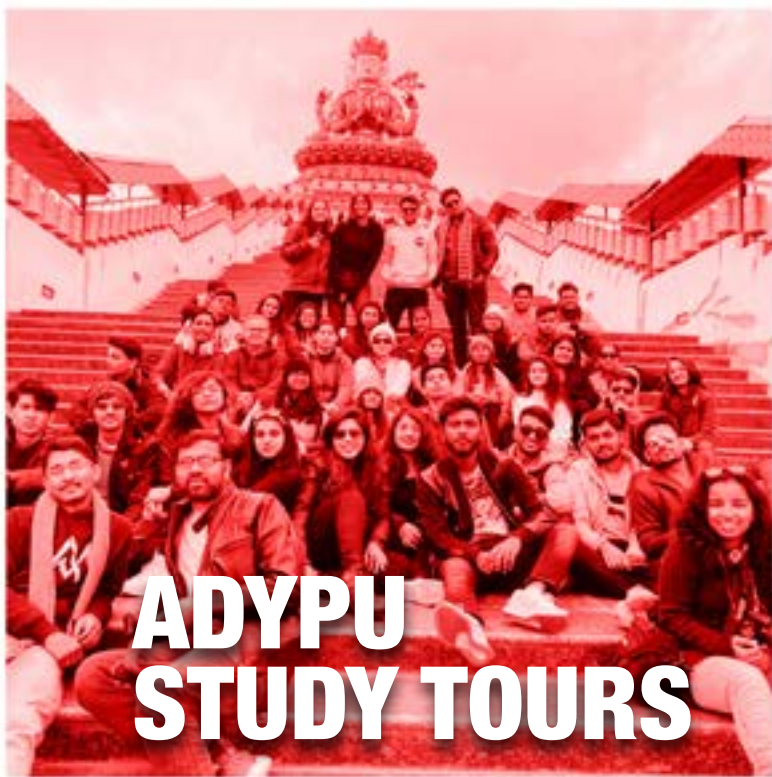
In case, the program fees are different, then the student will have to pay the difference in the fees or else the amount will be adjusted in the next instalment/ refunded to the student. However applicable administrative charges would be charged.

2. If the student applies for transfer of admission to another School of the University and his/her transfer is approved by the University then the first School from where the student has been transferred will hand over certificates/ documents to the student, to enable him/ her to submit the documents /certificates in the other School.
